



**May 9, 2017**  
**General Membership Meeting**

A General Membership Meeting of the Maryland Correctional Administrators Association (MCAA) was held on May 9, 2017 at 9:30 a.m. at the Turf Valley Country Club Conference Center in Howard County.

**Call to Order:** The meeting was called to order by President Lasher at 9:30 a.m. Sharon Tyler recorded the minutes. A quorum was present and the meeting, having been duly convened, was called to order.

**Presentations:**

- a) Prison Plumb Line – Yvonne and Robert Medley, prison ministers for over 20 years, started the Life Journey's Writer's Guild in the Charles County Detention Center. They provide monthly gatherings, workshops, literary projects and events, and literary therapy. The Prison Plumb Line is a lyrical drama based on the

reflections of five women in prison. The stage play is adapted from a novella and is described as energizing and empowering.
