Cfc Lara Hawbaker began her career as a Correctional Officer with the Frederick County Sheriff's Office Corrections Bureau in 2003. In 2017, Cfc Hawbaker opened the Moon-lit acres Animal Rescue and Rehabilitation Center, Inc, as a 501C3 non-profit organization in Saint Thomas, Pennsylvania. The Center is dedicated to animal welfare and the prevention of cruelty and suffering.

Cfc Hawbaker works closely with local police, Pennsylvania State Police, the District Attorney's Office and Humane Society in the tri-state area. When not working full-time as a correctional officer, she voluntarily conducts investigations in response to allegations of animal abuse and writes citations, applies for warrants or simply educates owners on the proper care of animals. She accompanies the police SWAT team to remove animals from crime scenes and has assisted in de-escalating highly emotionally charged and combative situations, sometimes made more difficult when drugs or alcohol are involved. Every time she responds to a call, she puts her life on the line.

She maintains a Facebook page for the Center to assist with education, fundraisers fostering, rescue and adoption of animals. Monies raised from donations support vaccines, vet appointments, treatment, housing, food, medication and surgery.

She recently worked with an elderly man whose wife had passed away and he couldn't care for a sick horse. Instead of writing him a citation, she connected him with a veterinarian and over the next two years, with the help of her family, assisted him with caring for his animals. On another occasion, she assisted an elderly woman with her pet because she couldn't navigate stairs. These are just a few examples of how Cfc Hawbaker assists members in her community.

Cfc Hawbaker donates a significant amount of her time and resources to this worthy cause. She responds to calls in her privately-owned vehicle and pays for classes to maintain her certification. Cfc Hawbaker does not take full credit for her efforts and acknowledges the support of her husband, children and community.

Cfc Hawbaker is highly deserving of this award. She is a hero who selflessly dedicates her time and resources to promote the positive image of animal care and rescue within her community.
